IV - Executive Report

-Secretary Creasman – made a few changes in the SAFF allocations proposal. In the old policy changed a few things. There was no chair person. The members were senators, now they are not. It said that things were to be reported to SGA, no specifics, he fixed that. When clubs apply for operational cost, now they can ask to transfer funds from budget committee. One of the bigger things we have done, added a section on funding suspension and relocation, saying if policies are violated, that the money can be frozen. And if this issues are not resolved they can be revoked. Catch all clause – funds can be frozen by Sec of Budget and President if there is a question in things that are occurring.
