CHRISTOPHER NEWPORT COLLEGE:
APPROVAL OF REVISED TUITION
SCHEDULE AND BOND FEE

Christopher Newport College, as the urban expression of The College of William and Mary, offers a comprehensive program during the day and evening hours for both part-time and full-time students. At the present time the full-time tuition rate is \$210 per semester for in-state students taking 12 or more hours. The part-time rate is \$20 per semester hour of credit with no distinction between in-state and out-of-state students.

The present tuition schedule is undesirable for the following reasons:

1. It does not provide for an equitable distribution of payment for services rendered. The student who takes 12 hours and the student who takes 18 hours pay the same tuition.
2. An increasingly large number of students (over 500 during the current semester) take a fifth or sixth course in the evening program on their full-time day tuition. This creates numerous viable classes in the evening program without a source of income to pay the salary of an adjunct instructor.
3. The part-time rate does not distinguish between in-state and out-of-state students.

The proposed revised tuition schedule, as described below, will correct the problems described above as follows:

1. Each student will pay tuition on a per credit hour basis up to and including 15 hours.
2. The student who registers for a course will pay the same rate whether the course is taught in the day or the evening.
3. The per credit hour schedule will distinguish between the in-state and out-of-state student, both part-time and full-time.

An additional consideration is the need to collect funds from students to support the construction of a Campus Center. A Bond Fee will be assessed as part of a comprehensive fee which will also be collected on a per credit hour basis.

The proposed schedule, as described below will generate the special revenue appropriated for the 1972-74 biennium and sufficient funds to support the anticipated revenue bonds.

The proposed revised tuition schedule is as follows:

In-State Students

Tuition	\$18 per semester hour of credit
Comprehensive Fee	\$ 2 per semester hour of credit

Out-of-State Students

Tuition	\$28 per semester hour of credit
Comprehensive Fee	\$ 2 per semester hour of credit

The comprehensive fee consists of a student activities fee and a building fee.

The effect of the new schedule may be ascertained from the following table:

Note: Present full-time tuition per semester for in-state students is \$210 plus a \$15 student activities fee. The full-time tuition per semester for out-of-state students is \$385 plus a student activities fee of \$15.

BE IT RESOLVED, That effective September 1, 1972, the tuition for in-state students be \$18 per semester hour of credit and that the comprehensive fee be \$2 per semester hour of credit.

AND, BE IT FURTHER RESOLVED, That effective September 1, 1972, the tuition for out-of-state students be \$28 per semester hour of credit and that the comprehensive fee be \$2 per semester hour of credit.
