Current Description:

The Bachelor of Arts degree in Modern Languages can be taken with a major in French, a major in German, or a major in Spanish. In addition to the required twenty-seven hours of course work above the 202 level in their area of major, all modern language majors must take MLAN 308, 490 and four semesters of a language different from the one of their major OR MLAN 308, two semesters of a language other than the one of their major, CLST 210, and either MLAN 205G or MLAN 206G. [...]

Proposed Revision:

The Bachelor of Arts degree in Modern Languages can be taken with a major in French, a major in German, or a major in Spanish. All modern languages majors must take MLAN 308 and MLAN 490 and select ONE of the following two tracks:

- 1. twenty-four hours of course work above the 202 level in their area of major
- 2. four semesters of a language different from the one of their major OR
- 1. twenty-seven hours of course work above the 202 level in their area of major
- 2. two semesters of a language different from the one of their major
- 3. MLAN 205 or MLAN 206

This is a currently existing program. Previously, if students chose to take only 2 semesters of a language outside of the major, they also had to take CLST 210 AND MLAN 205 or 206. Since the Classics section is considering deleting CLST 210 from the catalogue, we are replacing it with an additional course above 202 in the student's major language if this option is chosen for the BA in modern languages.
