- I. Call to order: Faculty Senate President Siochi called the meeting to order at 3:00 p.m.
- II. Dr. Siochi introduced the plan to honor retiring faculty at the Spring General Faculty Meeting.
- III. Recognition of Retiring Faculty
 - A. Dean Rameriz-Smith could not attend, so for the college of Liberal Arts Dr. Samuel Bauer read the following Resolutions.
 - 1. Resolution supporting Emeritus status for Dr. Rita C. Hubbard

WHEREAS Dr. Rita Cooper Hubbard, who for thirty-two years has been an exceptional scholar and educator at Christopher Newport University in the discipline of Communications Studies, and through her service, teaching and professional contributions has in immeasurable ways enriched the life of the University and her discipline,

AND WHEREAS Professor Hubbard is the founding chairperson of the Department of Fine and Performing Arts, the Department of Arts and Communication, and the Department of Communication Studies.

AND WHEREAS Dr. Hubbard has been instrumental in the development of the liberal arts focus at the University, as well as showing her commitment and dedication through her service to many committees such as the Faculty Senate and Faculty Review Committee,

AND WHEREAS Dr. Hubbard has demonstrated her diverse abilities within the classroom through the creation and teaching of a wide range of courses which are delivered with oratorical finesse and are intellectually stimulating, hence providing students a fertile ground for learning and life growth,

AND WHEREAS Professor Hubbard has published many articles and papers in prestigious communication journals such as *Communication Education, Communication Quarterly,* and *Studies in Popular Culture* as well as in various edited volumes, has made numerous presentations at national and regional conventions, and has served with distinction as an associate editor of *Communication Quarterly, Communication Course Annual,* and *Critical Studies in Mass Communications,*

AND WHEREAS Dr. Rita Hubbard has with a heart of devotion given to Christopher Newport University the best years of her professional life,

BE IT THEREFORE RESOLVED that Dr. Rita Cooper Hubbard be awarded the rank of Professor Emerita of Communication Studies in recognition of her continuing professional bond with Christopher Newport University.
