Continuing your Premium Rewards on you State Health Insurance Plan

Employees in the COVA Care or COVA HealthAware will have the opportunity to continue their premium rewards or start receiving their premium rewards for January 1 through June 30, 2014, by completing a Biometric Screening. Biometric screenings must be completed between August 1 and October 31, or have been done at a physician's office between April 1 and October 31, to count toward premium rewards for the second half of the plan year.

Biometric Screenings will be held in the David Student Union on August 1 and August 2 from 9:00 AM to 2:30 PM. Employees must schedule an appointment in order to receive the screening. To register for a screening, log on to the [MyActiveHealth](#) website.
