

403B AND 457 CONTRIBUTION LIMIT INCREASED FOR 2020

The IRS has increased the annual elective deferral limit for employee contributions into a 403(b) and/or the 457 supplemental retirement plans. Contribution limits increased from \$19,000 to \$19,500 in 2020. Employees age 50 or older may contribute up to an additional \$6,500 for a total of \$26,000.

Employees in a 403(b) with TIAA, Metlife, Lincoln, or Valic who wish to increase their contribution amounts beginning on your January 16th paycheck, should submit a completed Salary Reduction Agreement to the Office of Human Resources no later than December 20th (prior to the Holiday Break).

Employees wishing to increase 457 plan contributions should log into their <u>Defined Contribution Plan</u> account or call 1-877-327-5261.
