APPROVAL OF LOAN

Christopher Newport College

Christopher Newport College is now completing its most difficult biennium, financially speaking. Despite a 30% increase in enrollment in 1970, and a 16.8% increase in enrollment in 1971, the College was unable to function within the limits of the 1970-72 budget as prepared in 1969, and continue to develop as a four-year college.

The financial situation for fiscal 71-72 has been discussed personally with Mr. John R. McCutcheon, Director of the Budget, and in letters to him dated December 8, 1971, January 3, 1972, January 31, 1972 and March 7, 1972.

Mr. McCutcheon has advised the President of Christopher Newport College that the Governor of the Commonwealth has authorized, with his concurrence, the Rector and Visitors of the College of William and Mary, to borrow, on behalf of Christopher Newport College, a sum not to exceed \$125,250 from the State treasury for the fiscal year ending June 30, 1972 (authorization and note attached). It is further understood that funds for the repayment of this loan will be included in the 1974-76 Budget.

The loan described above will enable the College to complete the 1970-72 biennium with financial integrity and to enter the new biennium with the expectation that financial stability can continue.

BE IT RESOLVED, That the Board of Visitors approve a loan of \$125,250 from the State Treasury to Christopher Newport College for the fiscal year ending June 30, 1972, with the understanding that funds for the repayment of the loan will be included in the 1974-76 Budget.

It is further understood that funds for the repayment of the deficit, approved herein, will be included in the 1974-76 Budget.
