#### President's Report Dec.7, 2007

- 1. Building Program Initiatives Priorities:
  - "New" McMurran Hall: Demolition/Construction (Dec 07 Jun 09). Opening F09. Budgeted funds for furniture, fixtures, equipment are 3.2M. Departments scheduled to be in the building are: Communication Studies, English, Government, History, MAT, MCLL, Philosophy & Religious Studies, & Sociology. Process for finding homes for departments not mentioned is on-going. Schedule: Library vacate Dec. 10; Demolition: Jan-Feb; Construction starts: end of Feb 08 completed summer 09.
  - Science Center: Funding plans are proceeding potential state general bond.

  - Luter College of Decision Science building: Funding is planned in the state bond. Footprint will replace Wingfield Hall
  - Next Library Phase: Funding is planned in the state bond.
  - Freeman Center Addition (2010 opening): Funded by student fees.
  - "Student-Success Complex". Still in the planning stages.
- 2. In preparation for increased demand for adjuncts during our 4-3 transition, the CLAS Dean announced that the university will run a job advertisement early next year seeking adjunct faculty for AY 2008 2009. The deadline for requests is Tues., Dec. 11. The ad will be repeated later in the spring.
- 3. In the new year, President Whiting will work closely with Dean Gordon and Kevin Hughes to develop a "procedural-step" flow chart to help faculty deal with problem behavior in the classroom.
- 4. Following discussions with the registrar, because of the current setup of the software and limited personnel in the registrar office to allocate time to this duty, faculty awareness of students changing their status to pass-fail will have to depend on the information provided through Faculty Services on CNU Live.
- 5. The Provost has approved the Senate's proposed change to the 07/08 Catalog concerning Final Exam conflict/overload. It will read: "The University does not authorize re-examination nor will changes be permitted unless the student has 3 or more examinations in a calendar day. To request a change, the request must be made to the instructor."
- 6. Dr. William Ritchey was selected as the Director of Counseling Services.
