# APPROVAL OF BY-LAWS

# FOR THE PRESIDENT'S ADVISORY COUNCIL

Christopher Newport College

On May 19, 1973 the Board of Visitors approved the appointment of a President's Advisory Council for Christopher Newport College. It was understood that the Board would subsequently have an opportunity to review and approve the By-Laws under which the Council would operate.

By-Laws for the President's Advisory Council have been formulated and are attached. It is understood that the Council is advisory only, and that the Board of Visitors of the College of William and Mary will continue to make all policy decisions relative to Christopher Newport College.

BE IT RESOLVED, That the Board of Visitors of the College of William and Mary approves the attached By-Laws for the President's Advisory Council of Christopher Newport College.

# PROPOSED BY-LAWS PRESIDENT'S ADVISORY COUNCIL

# Article I

# Purpose and Responsibility

The President's Advisory Council of Christopher Newport College of The College of William and Mary has been established for the purpose of expressing the interests of the citizens of the Peninsula with regard to the conduct and needs of higher education at Christopher Newport College. It is the Council's responsibility to consult with and to advise the President of Christopher Newport College upon any related matters of concern to the citizens of the Peninsula area.

#### Article II

# Membership

- Section 1. The President's Advisory Council shall consist of twelve (12) and not more than fifteen (15) members and shall be representative, so far as possible, of the principal geographic jurisdictions of the Peninsula and the surrounding counties which are served by the College.
- Section 2. Members of the Advisory Council shall be appointed by the President of Christopher Newport College after consultation with the President and Board of Visitors of the College of William and Mary.
- Section 3. The Members of the Advisory Council shall be appointed for a term of four years on a staggered basis to provide continuity, such term to run from July 1. No member shall be appointed for more than two full successive terms.
- Section 4. Vacancies created in the Council's membership may be filled by the President of Christopher Newport College after consultation with the President and Board of Visitors of the College of William and Mary. A member serving the unfilled portion of a term shall be eligible for appointment to two full four-year terms. Council Members may be removed at any time by the President of Christopher Newport College upon recommendation by the Council and in consultation with the President and Board of Visitors of the College of William and Mary.
- Section 5. Any member who absents himself from three consecutive meetings, exclusive of absence for illness, shall be deemed to have submitted his resignation from the Council, and the Council may proceed to recommend persons to the President of Christopher Newport College to fill the vacancy.

### Article III

#### Officers

- Section 1. Officers of the Advisory Council shall consist of a Chairman and Vice Chairman, elected at the Annual Meeting of the Council. Nominations for these posts shall be made by the Nominating Committee. They shall be for a two-year term.
- Section 2. A Secretary, suggested by the Nominating Committee, but not necessarily a member of the Advisory Council, shall be elected at the Annual Meeting with responsibility for keeping the minutes of meetings, correspondence and other records.
- Section 3. The Chairman and in his absence, the Vice Chairman, and in their absence an elected Chairman pro tem, shall preside at all meetings of the Council.
- Section 4. The Annual Meeting shall be held in November for the purpose of a report on the state of the College, election of committee members and officers, and for such other business as may come before the meeting. Notice shall be sent to members at least ten (10) days before the meeting.
- Section 5. Regular meetings of the Council shall be called by the Chairman no less than six times a year, for the purpose of considering such business as may properly be brought before it.
- Section 6. Special meetings may be called by the Chairman or upon the wish of any five members with no less than three (3) days notice to all members unless otherwise waived.
- Section 7. The quorum for a duly called meeting at which votes are taken shall consist of a majority present of the membership of the full Council.
- Section 8. A vote upon any proposal at a meeting shall require the affirmative vote of a majority present for approval.

# Article IV

## **Standing Committees**

- Section 1. The Council shall at its Annual Meeting, upon advice of the Nominating Committee, elect the following Standing Committees: Executive Committee, Nominating Committee, Faculty and Academic Standards Committee, Planning and Budget Committee, and the Building and Grounds Committee. Each committee shall be composed of three or more members.
- Section 2. The Executive Committee, of which the Chairman and Vice Chairman shall be members, shall be empowered to meet and take such actions as may be required on behalf of the full Council, and will report all such actions to the Council at its next regular meeting.
- Section 3. Special committees other than those listed in Section 1, may be appointed, as circumstances require, by the Chairman of the Council.

# Article V

#### Finances

Members shall serve without compensation, any administrative expenses of the Council being borne by the College.

# Article VI

# Amendment of By-Laws

The By-laws of the Advisory Council may be amended by a two-thirds vote at any regular or special meeting, with prior approval of the President of Christopher Newport College and the President and Board of Visitors of the College of William and Mary, provided that at least five days written notice is given of intention to amend the By-laws at such meeting.

# RATIFICATION OF 1974-76 BIENNIAL BUDGET CHRISTOPHER NEWPORT COLLEGE

In a special meeting of the Board of Visitors on July 16, 1973, the Biennial Budget for 1974-76 was approved, subject to such modifications as might be necessary due to requirements of the Division of the Budget. The total approved at that time was \$7,506,645.

When actual rather than estimated expenditures for 1972-73 were used as a basis for calculation, as required by regulations, and when additional requests for equipment were added, the final edition of the budget reflected somewhat higher figures. These and other adjustments resulted in a final budget request of \$8,428,400, or an increase of 12.2% over the total budget presented at the July meeting.

RESOLVED, That the Board of Visitors hereby ratifies the operating budget for Christopher Newport College for the 1974-76 biennium in a total amount of \$8,428,400.
