## Faculty Senate Supported Changes to Faculty Evaluation System:

- 1. Promotion of associate professor and tenure would be combined into one evaluation.
- 2. Candidates would be evaluated in years 2, 4, and 6 rather than years 1, 2, 3, 4, 5 and 6. Contracts would be issues for three years, including an initial three year contract.
- 3. Peer groups would change their name to "department review group" and would consist of the chair, 3-5 tenured members of the department and one outside member chosen by the vice-provost from a list provided by the candidate. Department review groups would consist of tenured members only. Outside members will normally be chosen from within the candidate's division.
- 4. The faculty review committee (FRC) would consist of elected tenured members only (2 from each division). The provost would appoint one member at-large to make the total committee size of 9 faculty members.

## **3-3 Load Resolutions**

**Resolved**, That the Faculty Senate supports reaching the goal of 3-3 teaching load by implementing measures that the Faculty Senate considers to be in the interest of current and future faculty and students, and the integrity of academic programs.

## **Faculty loads of 4-4, 4-3, and 3-3**

**Resolved**, That the Faculty Senate supports the incorporation of faculty teaching loads into the evaluation system by the start of Fall 2009.


## **Faculty conversion**

**Resolved**, The Faculty Senate supports the faculty developing a mechanism by 2010 whereby faculty with a 4-3 load, who desire to do so, would be considered for a 3-3 load no later than 2013.

## **Review Order**

- A parallel review was adopted where FRC and Dean would produce independent reviews based on the primary DRC (department) review and dossier.
- -FRC and Dean would report directly to the Provost Provost provides these reviews to the Candidate and DRC chair for comment (also reported directly back to the Provost).

#### **Parallel Review Proposal**



**Resolved,** That the Faculty Senate recommends that CNU adopts a Parallel review model for a trial test to be followed by a post-trial evaluation, developed by the Faculty Senate during the 2008-2009 academic year.

### **MENTORING PROGRAM for Probationary Faculty**

Faculty Senate proposed to organize and oversee:

## **Mentoring Committee** (setup initially by FS – then elected)

- find tenured faculty to be mentors
- mentorship would be recognized as service
- mentor (outside junior faculty department) offered to junior faculty during their first 3 years
- appointment made by mentoring committee
- relationship controlled by junior faculty
- junior faculty member can request a change in mentors without prejudice or fault.
- mentor plays no evaluative role
- mentor should be sounding board and confidant

## Suggested **Sponsor Program** within each Department

- within department sponsor to facilitate new faculty member's integration into the department and university community.
- Organized by each Department
- Address department policies, EVAL-4, course syllabus development, etc.

## Parking Advisory/Appeals Committee (PAAC)

The Parking Advisory/Appeals Committee (PAAC) shall consist of the Director of Parking and Transportation (Chair), two Faculty members nominated by the Faculty Senate and appointed by the President for 2 year terms, two Staff members, and two Student representatives nominated by the SGA and appointed by the President.

The purpose of this committee is to discuss, propose and implement changes to parking policy, rules and regulations. The committee will also provide a structured means to appeal a citation after the initial appeal has been denied.


