## FACULTY APPOINTMENTS TO FILL NEW POSITIONS

### Christopher Newport College

Because of increase in enrollment and expansion of academic programs, it is necessary to employ an additional faculty member in the Department of Mathematics. Academic rank is established in conformity with standards set by the Christopher Newport College faculty. Salary is consistent with other faculty members at the College with comparable educational background, experience, and rank.

THEREFORE, BE IT RESOLVED, That the Board of Visitors of The College of William and Mary and Christopher Newport College hereby approves the establishment of the new faculty position indicated below and the appointment of the following person to this position, at the rank and salary stipulated:

DR. MARTIN BARTELT, Assistant Professor, in the Department of Mathematics, at a salary of \$14,750.

B. A. , Hofstra College, New York, 1963;  
M. A. , Mathematics, University of Wisconsin, Madison, 1965;  
Ph. D. , University of Wisconsin, Madison, 1969.

Dr. Bartelt currently is Assistant Professor of Mathematics at Rensselaer Polytechnic Institute, where he has taught full-time since 1969, except for 1973-74, when he taught at the University of Rhode Island. Dr. Bartelt has authored and published widely in professional journals during the past several years.

PROFESSIONAL DEVELOPMENT GRANTS

Christopher Newport College

Christopher Newport College is very concerned about opportunities for professional development for the Faculty, and during the past two years has instituted a formal program of professional development awards. Last year, \$10,500 was made available for this purpose. This year, \$12,000 has been designated. In a first round of faculty applications, the following development grants were recommended by the Faculty Advisory Committee, and have the approval of the Dean of Academic Affairs and the President:

Professor Robert Durel - \$1,200. for research in evaluation research and inter-organizational relationships;

Professor John Freiden - \$500. for dissertation research;

Professor John Harwood - \$1,000. for dissertation research (declined).

Professor Rita Hubbard - \$202.17 to participate in Creative Writing Workshop;

Professor Aletha Markusen - \$600. for advanced research in Immunology;

Professor William Parks - \$1,200. for research on the influence of 18th Century European ideas in America;

Professor Lea Pellett - \$800. for work toward completion of the MSW degree;

Professor Fran Slocumb - \$459. for work toward completion of the Ph. D. ;

Professor Mary Anne Swindlehurst -  
\$355. for study to maintain good standing as a Certified Public Accountant;

Professor Gary Vazzana - \$215.20 for summer study in small business management;

Professor William Winter - \$800. for dissertation research.

Professional development projects are supported as part of the College's total plan of faculty compensation.

Because of the resignation of the Director of Computer Services and Institutional Studies, it is necessary to employ a new person for this administrative position.

BE IT RESOLVED, That the Board of Visitors of the College of William and Mary and Christopher Newport College hereby approves the following appointment:

MR. E. M. STAMAN, Assistant Professor, at a salary of \$18,000.

Mr. Staman has an A.B. in Mathematics from Elizabethtown College, Pennsylvania, 1964; an M.S. in Computer Science from The Pennsylvania State University, 1966; has attended National Science Foundation Institute in Computer Science (August, 1967), has earned credits in Economics (1968) at The George Washington University, Washington, D. C. , and has earned forty additional credits in Mathematics and Computer Science (1964-1966 and 1969-1972) at The Pennsylvania State University.

His publications include:

He was a Research Assistant - member of the Administrative Group in the Computation Center at The Pennsylvania State University, from August, 1969 to June, 1973, and from July, 1973 to the present, he has been Director of the Computer Center at Union County Technical Institute.
