Other examples, not many people seem to be that passionate either way. Giving VT example, seem to think they can go other places start to cut out meal plans. From upperclassmen
- xiv. Senator Blunt: most people are uneducated about this, need to have publications about pro/con chart. Need to educate student body as whole.
- xv. Senator Mays: agreeal with Senator Blunt, town hall coming soon, should not keep pushing this off.
- xvi. Senator Mascia: students were impartial. Keep on comparing us to other schools. Inconvineent time for some people for townhall meeting

- xxi. Sgt. At Arms Dermer: what is asked from the student body, is not what the public wants, we need to look out for what's best for the student body. Gladly to entertain, to add section onto bill: we should have time period as to look at new SU before we take this further.
- xxii. Peanut Gallery (Ashley Moyer): RA- most students don't know what is going on, we need to have a clear picture of what is happeneing, and we need to be informed as to make the best decision. We should not push this through so soon.
