Re: Request for multiple changes in Theater & Dance curriculum



Dear Colleagues,

The Department of Theater and Dance is currently pursuing accreditation by the National Association of Schools of Theater (NAST). In preparation for this process, the department employed a NAST consultant to review our program and undertook an exhaustive self-study this past summer (self-study available upon request). One of the results of these endeavors is the collection of forms which this memo accompanies, some 40+ pages in all. These changes, the majority of which are minor, are designed to improve our overall curriculum and bring it inline with the national norms as specified and detailed by NAST. The following is a summary of these changes.

I. Theater Core Curriculum

- Total number of Credit Hours required by the core reduced from 26 to 23
- THEA 100 will become an introduction to play analysis
- THEA 210 and 211 will shift focus from dramatic styles to historical perspective
 - o Only sections "For Majors" will be affected
- THEA 250 and 252 will add scenic and costume design assignments, respectively

II. Music-Theater/Dance Concentration

- Total hours for concentration reduced to 30 (uniform for all artistic emphases)
- Five credits in vocal training increased to six
- Removal of "Select one: THEA 332, 334, 430, 431" Requirement

III. Design/Technical Theater Concentration

- Removal of requirement of THEA 232 (Scene Painting)
- Change total of approved elective hours from 12 to 15

IV. Directing/Dramatic Literature Concentration

- Total hours for concentration increases to 30 (uniform for all artistic emphases)
- Add THEA 233 (Pursuit of Realism) to required courses

V. Arts Administration Concentration

- Total hours for concentration increased to 30 (uniform for all artistic emphases)
- GOVT 385 and 401 removed from requirements (No longer exist)
- PSYC 313 Removed from requirements
- THEA 451 added to requirements
- LDSP (Leadership) 220 and 310 added to requirements
- COMM 310 added to optional choices
- Three semesters of THEA 200L now replace three semesters of 250L in the core

VI. Theater Studies Concentration

- New concentration to be added
- Total hours for concentration: 24
- Curricular requirements of concentration as follows:
 - o THEA 336
 - o Select one: THEA 354^{\(\)}, 356^{\(\)} or 452^{\(\)}
 - o Select one: THEA 242, 261, 361, 366, 370 or other upper level theater literature course.
 - Fifteen additional hours of approved Theater electives, of which there can be a maximum of 6 hours of performance classes, a maximum of 6 hours of design classes and a maximum of 6 hours of dance classes.
 - o Successful completion of the Theater Graduation Examination

VIII. Theater Major with Distinction Program

- New Program
- To recognize students of high achievement and significant departmental involvement and to provide tangible goals for current majors.

The Theater Studies concentration gives students a comprehensive experience, equally combining theoretical and practical courses. The curriculum is purposefully flexible allowing students to choose from the wide range of subdisciplines of theater. While students will pursue their individual theatrical interests they do so within the context of a broader understanding of theater, which opens the mind to larger questions of psychology, social identity and history. Students are encouraged to augment their studies with cognate disciplines such as music, art, English, history, philosophy, religious studies, mathematics or foreign languages. The Theater Studies concentration prepares students for graduate study in theater criticism, history, and scholarship and is ideal for those wishing to pursue the Master of Arts in Teaching.

3. What are the objectives for this program?

The Theater Studies concentration can prepare students for graduate study in theater history and criticism and is and ideal concentration for those wishing to pursue the Master of Arts in Teaching. Additionally, this concentration serves the true theater generalist who does not wish to focus in any one artistic area.

4. For whom is the new curriculum primarily intended? Explain why it should become part of the curriculum, and how this proposal relates to the University's mission.

The Theater Studies Concentration has been designed for the theater generalist who desires a broad understanding of the art form without a particular specialization. It provides the program with an avenue of study for students whose talents may lie in the world of theory rather than practical artistic application. The concentration's greater use of targeted electives embraces the University's commitment to liberal learning and is directly applicable to students interested in the MAT.

5. What is the anticipated enrollment in the new curriculum for the next three years?
We anticipate 20-30 students will be enrolled in Theater Studies over the next three years

Current faculty and staff are sufficient for this new concentration.
