FACULTY APPOINTMENTS TO FILL NEW POSITIONS

Christopher Newport College

Because of increases in enrollment and expansion of academic programs, it is necessary to employ additional faculty in the Departments of Basic Studies, Business, Education, Fine and Performing Arts, Government, Physics, and Sociology. Academic rank is established in conformity with the standards set by the CNC Faculty. Salaries are consistent with other faculty members at the College with comparable educational background and experience.

BE IT RESOLVED, That the Board of Visitors of the College of William and Mary hereby approves the establishment of the permanent new faculty positions indicated below and the appointment of the following persons designated by rank and salary for these positions:

JOHN T. HARWOOD, Assistant Professor in the Department of Basic Studies (Writing), at a salary of \$12,500.

STAVROULA E. KOSTAKI, Instructor in the Department of Basic Studies (Mathematics), at a salary of \$11,750.

JON B. FREIDEN, Assistant Professor of Business Administration (Marketing), at a salary of \$14,000.

STUART C. VAN ORDEN, Associate Professor in the Department of Fine and Performing Arts (Art), at a salary of \$14,500.

PAUL KILLAM, Assistant Professor in the Department of Political Science (Urban Planning), at a salary of \$13,500.

A. M. BUONCRISTIANI, Associate Professor in the Department of Physics, at a salary of \$14,050.

RONALD R. FENNELL, Assistant Professor and Director of Social Work in the Department of Sociology (Social Work), at a salary of \$11,800.
